

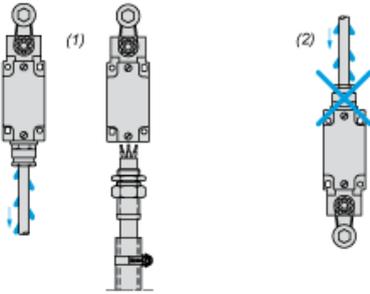

Position of Cable Gland





Type of Cam



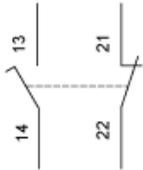

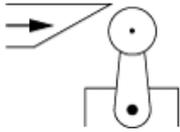


Switch Actuation by 30° Cam
