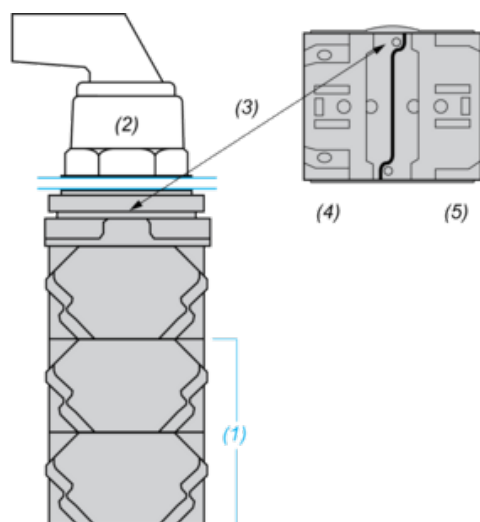

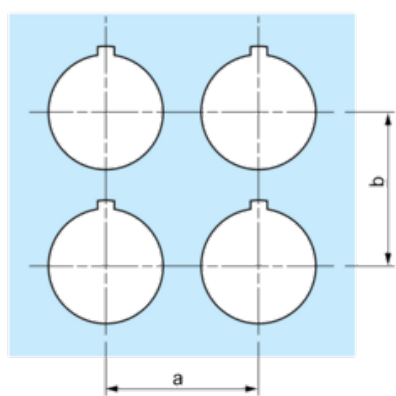
Top and Rear views

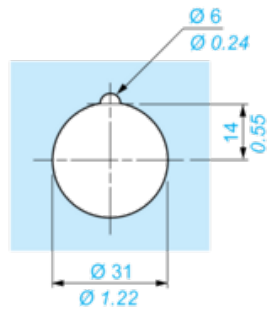
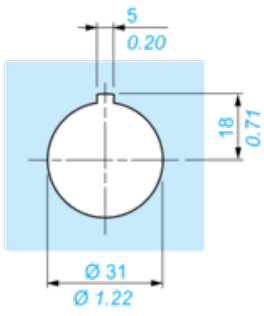
